

Testimony John Jamison - I know Henry Jamison, son of Baker Jamison - shortly after the death of Baker Jamison. I was at the house & suggested to Henry that as he had already had a full share of his father's Estate by previous advances and as the Estate was very small, he should assign, or release his Interest in the Estate to his sisters, who were without means of support. He at once agreed to do so. & at his request I drew a release, of his Interest in his father's Estate, in favor of his sisters & he executed it. what was done with this Release I do not with certainty know, but my impression is that it was placed into the hands of William Lee Exr of Baker Jamison.
