

seized, and possessed of personal property of small value and certain Real Estate, lying, and being in Frederick County, and State of Maryland known as part of Lot No 4, which is part of Lot No 2, all part of a Tract of Land called 'New Bremen' a more full and complete description of which Real Estate is contained in a Copy of the deed for the same for the same from Geo L Davis to the said Alfred Basford, herewith filed, and marked, Exhibit 13. And your orator further charges, that administration of all & singular, the personal property of the said Alfred Basford, has been granted by the Orphans Court of Frederick County, unto one Abraham Bittenberger of said County, who in virtue thereof has possession himself of, and fully settled and paid out said personal Estate in discharge of the debts of said decd as far as said Estate would reach; but your orator charges, that the said personal Estate was greatly insufficient to discharge in full the debts due, and owing by said decd at the time of his death, and that any deficiency in the said personal Estate for the payment of said debts, ought to be supplied by the sale of the Real Estate of the aforesaid debtor. And your orator further states that the said decd left at the time of his death, the following children and heirs at Law, all of whom are still living. Viz John Basford Ellen Basford Eliza Basford, Henry Basford, Charlotte Basford, Susan Basford George Basford Alfred Basford & Adam Basford of whom the said John Basford Ellen Basford Eliza and Basford are of the full and lawful age of Twenty one years, and that the said Ellen Basford has removed to, & resides in the State of Virginia, all the rest of said children reside in Frederick County, State of Maryland. But now so it is that your orator is unable to obtain, adequate relief, against the aforesaid Real Estate, without the aid of your Honorable Court So the end therefore, that the aforesaid Real Estate, or so much thereof, as may be necessary for the purpose may be decreed, to be sold, for the payment of so much of the aforesaid debts as remain unsatisfied by the application of the personal Estate of said decd. as aforesaid May it please your Honor to grant unto your orator, an Order of Publication, giving notice to said Ellen Basford the said absent defendant of the substance, and object of this Bill, thereby warning her, to be, and appear in this Court in person or by solicitor, on or before a certain day, to answer the premises, and shew cause if any she has, why a Decree shall not pass as prayed. And may it please your Honor to grant unto your orator, the writ of Subpoena against the said Abraham Bittenberger administrator as aforesaid, John Basford, Eliza Basford, Henry Basford, Charlotte Basford Susan Basford George Basford, Alfred Basford, and Adam Basford of Frederick County aforesaid, commanding them to appear in this Court, at some certain day, to be therein named to obey and perform such decree as may be passed, in the premises and as in duty bound your orator will ever pray &c
