 The Bill of Complaint of George  
 Abrecht & Mary Abrecht his  
 wife, Mary Oliver, and Ann Hatter of the State of Ohio and of Philip  
 Kamm, and Barbara Kamm his wife, and John Abrecht & Rebecca -  
 Abrecht his wife of Frederick County, and State of Maryland, Res-  
 pectfully represents unto your Honourable Court; That a certain  
 George Abrecht, late of Frederick County dec'd departed this life, in  
 or about the year eighties Hundred and Twenty Eight seized and  
 possessed of certain Real Estate, lying and being in Frederick -  
 County, and State aforesaid, to wit; Lot No 16 an additional lot  
 to Frederick Town, said lot being part of a Tract of Land called "Long  
 acre" which was part of Pasture Chanc'd. The said lot, being more  
 fully described, in the Copy of a Deed for the same, herewith filed -  
 marked Exhibit A which with all other exhibits, herewith filed -  
 your Orators, and Oratrices pray may be taken & considered as a  
 part of this their Bill of Complaint, and your Orators further -  
 state, that the said, George Abrecht, dec'd. died intestate, leaving -  
 a widow Magdalena Abrecht and the following children & heirs  
 at Law, of whom are now living, and upwards of Twenty one years  
 of age, to wit; Mary Oliver a daughter, who intermarried with a  
 man of that name, and who has since died; Ann Hatter also a  
 daughter of said deceased, who intermarried with a man of that -  
 name, also since dec'd. George Abrecht a son, intermarried with  
 a certain Mary Jeffers, all of whom reside in the State of Ohio  
 Barbara a daughter, intermarried with Philip Kamm, Catharine  
 a daughter, intermarried with a certain William Pool; John -  
 Abrecht a son intermarried with Rebecca Wills of Williams Abrecht  
 a son, intermarried, with a certain Sarah Eckelbarger, all of whom  
 reside in Frederick County Maryland. That soon after the death -  
 of the said George Abrecht, the following of his said children & heirs  
 at Law to wit, George Abrecht John Abrecht William Abrecht  
 William Pool, and Catharine his wife, and Philip Kamm, deeded -  
 their Interest, in the said property to their mother, the said -  
 Magdalena Abrecht, for & during her natural life, which  
 deed is dated, the Ninth day of April in the year Eighteen -  
 Hundred and Twenty Eight, all of which, will more fully appear  
 by a Copy of said Deed herewith filed marked Exhibit B the said  
 Magdalena Abrecht, the grantee, in the said Deed, departed this -  
 life, a few months ago and that William Abrecht, one of the -  
 said children of said dec'd. George Abrecht became an applicant  
 for the benefit of the Insolvent Laws of Maryland, on the 18<sup>th</sup> -
