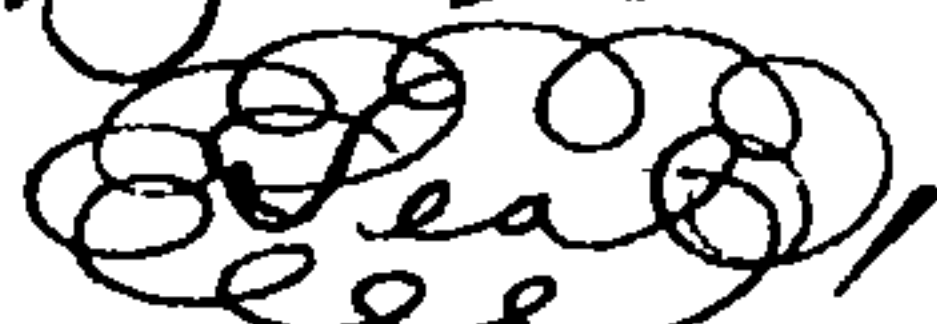

At the request of Jacob Wastey the following deed is Recorded, 4 Sept 1838 This Indenture - made this 21st day of August, in the year of our Lord one thousand eight hundred and thirty eight, between Abraham Blessing of Geo of Frederick County, and State of Maryland of the one part, and Jacob Wastey of the County & State aforesaid of the other part; Whereas David Stockman & Sophy his wife of the said County of Frederick, did on the 25 day of January - 1837 by their deed of Mortgage duly executed & Recorded, grant, bargain and sell release, and Confirm, unto the said Abraham Blessing and Jacob Wastey, all those two Lots, or parcels of ground, situate, lying, and being in the Town of Jefferson, in the aforesaid, known & distinguished on the plat of said Town, by No 61 to be released on the payment of the sum of money therein mentioned, for the payment of which the said Abraham Blessing, and Jacob Wastey were bound as the Securities of the said David Stockman, and the said Abraham Blessing - being fully released from the Security ship aforesaid hath given to the said Jacob Wastey This Instrument of writing. Now This Indenture - Witnesseth - That the said Abraham Blessing for & in Consideration of the above recited premises, and for the Consideration of the sum of five dollars current money to him, by the said Jacob Wastey, in hand paid, hath granted, bargained sold released assigned, and Confirmed, and by these presents hath grant, bargain sold released assign, and Confirm unto the said Jacob Wastey, his heirs, & assigns, all the right Title Interest Claim & demands of him the said Abraham Blessing of unto, & upon the said Mortgage premises, and appurtenances thereunto belonging or in any wise appertaining so that and to hold the said two Lots of ground, and premises, with the appurtenances, unto him the said Jacob Wastey his heirs and assigns, according to the true Intent & meaning - of the deed of Mortgage aforesaid. In Witness whereof the said Abraham Blessing hath hereunto subscribed his name, & affixed his Seal, the day & year first herein before written.
