Schley to Robert Schley for \$392 10 & of Edward Schley to Robert Schley for \$300. were retained by his deceased father David Schley

John J. Schley being duly sworn deposes that the 392\$ was in fact received by David Schley. Edward Schley deposes that he paid by note mentioned in statement N^o 35 for \$300 to David Schley The Solicitor for Complainant, after hearing the above testimony, admits the correctness of the account (as stated), and the Special Auditor proceeds to state an account on that basis
