


I also give, and bequeath to my aforesaid wife, one good feather Bed, Bedstead and bedding to be her finally
 I give and bequeath to my son in law Samuel Hull the sum of eight hundred Dollars, on the following Condition that he well take charge of my son Elias and keep or have him kept during his life & at his death have him decently burried, it is to be understood the above mentioned Eight hundred Dollars is for the support of my son Elias that the aforesaid Hull is to have the whole amount for so doing.
 It is also my wish & desire - That my Executors sell the Farm, where I now live lying and being in Frederick County, and State aforesaid adjoining Land with Jacob Shoemaker, William Whatter, & others containing one thousand & thirty two acres of Land, and the proceeds of the sale of said Farm to be disposed of as follows giving my Executor full power, and authority to sell the aforesaid property, without an order from the Orphans Court at Public sale as soon as can be most convenient after my decease, and to convey to the purchaser or purchasers by a good deed, the aforesaid property it is my will and desire, that my Executors sell all my personal Property, Except that is already bequeathed to my aforesaid wife, here to sell at public sale, without an order from the Orphans Court out of the money arising out of the sale of the Real property, and also the proceeds of the sale of the personal property my Executor first pay to my wife Anne Elizabeth Sheets, the sum of Eight hundred Dollars Next the sum of Eight hundred Dollars, for the support of my son Elias which is already mentioned, and the balance of the money arising from the sale of the aforesaid property, both Real and personal to be divided equally share and share alike, between my other my Children namely To my daughter Mary Harbaugh, Susannah who intermarried with Samuel Hull Jacob Sheets Mathias Sheets Sebella Sheets, who intermarried with John Sheets & Lewis Sheets, their heirs, & assigns forever. And lastly I do hereby constitute and appoint my son in law Samuel Hull, to be sole executor of this my last will & Testament revoking & annulling all former wills by me heretofore made, ratifying & confirming this and none other to be my last will & Testament In Testimony whereof I have hereunto set my hand, & affixed my seal this 5th day of February. 1851
