29<sup>th</sup> October 1839.

This Indenture made this ninth day of May 1839 between William Creeger, and Elizabeth Creeger his wife of Frederick County, State of Maryland of the one part, and William Miller Sen' of the same County & State of the other part. Witnesseth - That for and in Consideration of the sum of sixty Dollars, Current money - by the said William Miller Sen' to the said William Creeger & Elizabeth Creeger his wife, in hand paid, at & before the sealing, and delivery of these presents, the receipt of which they doth hereby acknowledge the said William Creeger, and Elizabeth Creeger his wife hath bargained and sold, aliened and conveyed, and by these presents doth give grant bargain and sell, aliened and conveyed release Convey & Confirm unto the said William Miller Sen' his heirs & assigns the following - piece or part of a Tract of Land, Situate & lying in Frederick County - aforesaid known as The Onontario Tract, bounded on the East by the Land of a certain Washington A. Deem & thereof by the Land of Christian & John Seaver, on the West by the Land of the heirs of -
