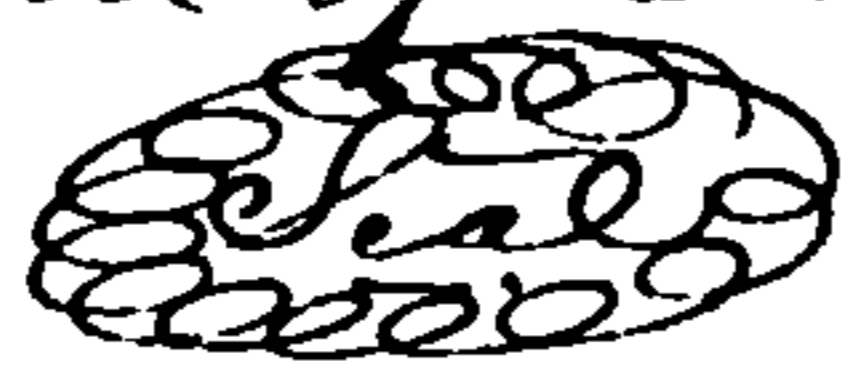


Which is thus endorsed Viz. State of Maryland, Frederick County &c

This Indenture - made this 1<sup>st</sup> day of September 1857 between Zachariah  
 Miller, one of the children, & heirs at Law of William Miller late of  
 Frederick County in the State of Maryland dec'd of the one part and  
 Thomas A Miller brother of the said Zachariah of the County & State  
 aforesaid of the other part Whereas the said Zachariah Miller, for  
 and in consideration of the several Covenants & agreements hereinafter  
 mentioned, in further Consideration of Five Dollars, current  
 money, to him in hand paid by the said Thomas A Miller, at & be-  
 fore the sealing & delivery of these presents, the receipt whereof is  
 hereby acknowledged, hath granted bargained assigned set over aliened  
 enfeoffed, and by these presents doth grant, bargain assign,  
 alien enfeoff, convey and confirm, and set over unto the said  
 Thomas A Miller, all the right, Title & Interest, Share & Estate of  
 said Zachariah Miller, of in and to all the Real, and personal Estate  
 of which W<sup>m</sup> Miller dec'd died seized and possessed, and which he  
 the said Zachariah Miller is entitled as one of the children & heirs  
 at Law of said W<sup>m</sup> Miller, situate and lying in Frederick County.

To Have and to hold the said described Interest  
 in and to said Real and personal Estate, unto him the said Thomas A  
 Miller, his heirs, executors, administrators & assigns forever -
