

are held, and fully bound unto John Randolph Shafer and Robert Shafer in the full and just sum of six thousand Dollars current money to be paid to said - John Randolph Shafer, and Robert Shafer their executors administrators or assigns to which payment well and truly to be made & done we bind ourselves & each of us our heirs executors & administrators jointly & severally firmly by these presents. sealed with our seals and dated this eighth day of August in the year Eighteen hundred and forty eight Whereas by audit made in N^o 2094 Equity Docket of Frederick County Court the sum of Two thousand Three Hundred, and Thirty Seven Dollars Thirty six & one tenth Cents, has been audited to Margaret Rontzahn by the audit made and finally ratified and whereas the said Margaret Rontzahn is entitled to an Equitable settlement out of the said sum of money & whereas said John Randolph Shafer and Robert Shafer trustees in said Cause have at the request and solicitation of Ezra A Rontzong - the husband of said Margaret Rontzong - agreed to pay over to said Ezra A Rontzong the said sum of money so audited to said Margaret Rontzong upon being indemnified from all less costs suits actions, & demands, for and on account of said sum of money made or to be made by the said Margaret Rontzong, or any person, or persons claiming by from or under her Now the Condition of the above obligation is such - That if the above bounden Ezra A Rontzong shall well and truly indemnify & save harmless the said John Randolph Shafer & Robert Shafer, from all less costs charges Damages suits actions, Claims & demands at Law & in Equity for & on account of said sum of money, audited to said Margaret Rontzong and paid to said Ezra A Rontzong and shall repay the said sum of money - together with the Interest, accruing thereon, and all costs to said John Randolph Shafer & Robert Shafer, in case the said Margaret A Rontzong or any person claiming under her shall recover the said sum of money from the said John Randolph Shafer and Robert Shafer Trustees then this obligation to be void otherwise to be & remain in full force in Law




 a Lunatic }
 It appearing to the Court here from the return of Caspar Mantz Sheriff of Frederick County - That the Petition of Thomas Shafer Trustee of Margaret Rontzong the Lunatic and the order there passed thereon by this Court had been duly served by said Sheriff on John Randolph Shafer, and Robert Shafer Trustees in N^o 2094 Equity according to the said order and no cause having been shown by the said Trustees, on the day limited in the said order It is thereupon this 9th day of May 1853 by Madison Nelson Circuit Judge of the third Judicial Circuit for the State of Maryland sitting in Equity, and by the authority of the Circuit Court for Frederick County sitting in Equity Ordered - that the sum of Two thousand Three Hundred & Thirty Seven Dollars & Thirty six cents be settled upon Margaret Rontzong for her own use during her life and after her death, for the use of her children and that John Randolph Shafer & Robert Shafer Trustees pay to Thomas Shafer as Trustee for said Margaret Rontzong - the said sum of money the balance of which after deducting the costs of the Lunacy Case and the costs of this proceeding to be invested by him in some safe security the Interest on which shall be applied, for the maintenance & support of the said
