

Provided always & it is declared to be the true intent, and meaning of these presents, and of the said parties hereto that if the said Solomon Snowden, his heirs Executors or administrators do and shall well and truly pay - or caused to be paid unto the said Frederick Town Savings Institution the said full sum of One Thousand & Eighty dollars, Current money in the said Note specified, when the same shall become due & demanded by the said Savings Institution or shall renew the same from time to time Provided said Savings Institution shall give its assent to such renewal, and shall well, and truly pay such renewal when the same demanded, and all discounts thereon, thereby saving harmless the said Egn Doubl, and George Gettinger from all law costs damages and charges by reason of said Security - ship then these presents, and every matter, and thing therein contained shall cease and be utterly null and void, any thing herein contained to the contrary in any wise notwithstanding In Testimony whereof the said Solomon Snowden hath hereunto set his hand, and affixed his seal the day & year first herein before written
