

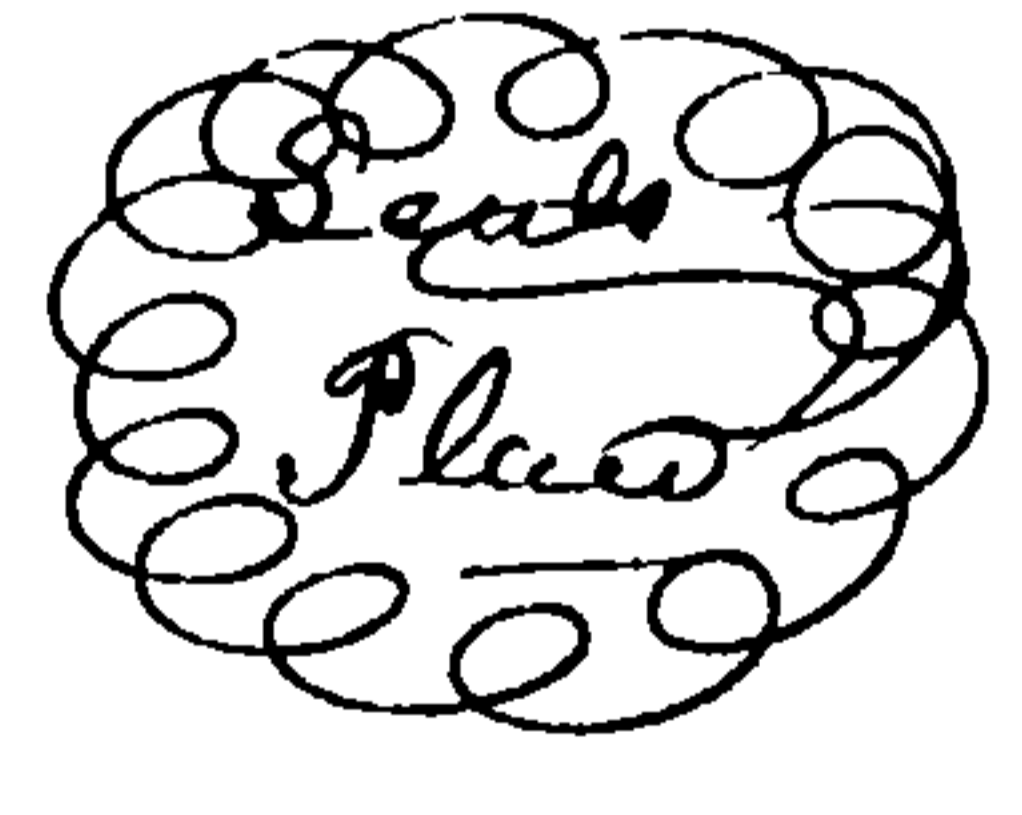

At the request of James W Baughen - The following Deed is Recorded August 11. 1848 This Indenture - made this Eleventh day of August in the year of our Lord one Thousand Eight hundred and Forty eight between Daniel G Gettier of Frederick County, and State of Maryland of the one part & James W Baughen of the County & State aforesaid - of the other part. Whereas the said Daniel G Gettier by his certain promissory Note duly executed upon Stamp paper agreeable to Law bearing even date herewith stands indebted unto the said James W Baughen in the just and full sum of eight hundred and Sixty seven dollars current money, payable six months after date, with Interest from date, as by reference to said note will fully appear, and to secure payment
