To the second Interrogatory he answers he did know Daniel G Gettier formerly of Emmittsburg, in Frederick County he is now dead he died during the past winter in the City of Baltimore & left a widow Elizabeth Gettier and the following named children all of whom reside in the City of Baltimore Joseph A John May William Rose Edward Peter & George they are all Infants under 21 years, of age except Joseph A Gettier who is about the age of Twenty one years To the third Int he answers he is acquainted with the hand writing of Daniel G Gettier deponent has looked upon the papers now shown him and filed with the Bill marked Exhibit N° 1 N° 2 N° 3 N° 4 N° 5 N° 6 N° 7 N° 8 and states that the signatures thereto are in the hand writing of Daniel G Gettier - deponent has frequently seen said Gettier write his name

To the fourth Inty deponent answers that Daniel G Gettier was seized of a house & Lot of ground in the Town of Emmittsburg known as the Emmittsburg Hotel. deponent has looked upon the papers now shown him, and filed with the Bill marked Exhibits A B & C and the property therein described is the same of which the said Daniel G Gettier was seized and possessed He has full knowledge of this as he has been frequently on the premises.
