

upon which said personal Estate letters of administration were regularly and in due form of law, granted by the Orphans Court of Frederick County, to Samuel B Preston of said County who in virtue thereof possessed himself of the said personal Estate and has fully administered the same your Orator charges that the personal Estate of the said John D Rooney is greatly insufficient to pay and satisfy the Debts due to your orator, and other Creditors of said John D Rooney - That the said administrator has settled his first & final account, in the Orphans Court of Frederick County and that the personal Estate of said Interlate, was so inconsiderable that the same was absorbed entirely in the payment of the funeral expenses &c of the Dec<sup>d</sup> leaving nothing to be distributed to your orator, and other Creditors of said John D Rooney all which will more fully and particularly appear by reference to a Certified Copy of said account herewith exhibited marked exhibit A and filed as part of the bill and your orator avers and hereby charges - that the aforesaid several Debts due as aforesaid to your orator still remain unsatisfied, and unpaid & that without recourse to the said Lot, or parcel of Land & appurtenances, there was no realisable property left by the said Dec<sup>d</sup> which is liable for the payment of the Debts due to your orator and other Creditors and as your orator is sensible in the premises otherwise than by the interposition of your Honourable Court, he exhibits this - his bill of Complaint - To the end therefore - That the Defendants herein after named may answer the several matters, and things herein before set forth as fully and particularly as if the same were here again repeated, and they were particularly interrogated thereto and that the said Dec<sup>d</sup> from the said John D Rooney to said Mary Ann Rooney his wife may by a Decree of this Honourable Court be annulled vacated and set aside, and the same may be declared fraudulent and void, as against your orator, and other Creditors who will come in & contribute to the expenses to the expenses of this suit, and that a Justice may be appointed by your Honourable Court to make sale of the said Lot, or parcel of ground with the appurtenances, herein before mentioned, and described or so much thereof, as may be necessary to pay the aforesaid Debts due to your orator, and other Creditors and that your orator may have all such further, and other relief in the premises - that the nature of the case may require & so forth May it please your Honour to grant unto your orator the writ of Subpoena against the said Margaret Rooney John Rooney Joseph Rooney Alice Rooney & Catharine Rooney and Samuel B Preston administrator of John D Rooney dec<sup>d</sup> Commanding them, and each of them to appear in this Court, at some certain day to be therein named to answer the premises, and obey & perform such Order, and Decree as may be passed therein and as in duty bound &c
