your Complainant further states - that the personal Estate of the said Jacob Flook of Ind. is wholly insufficient to pay his debts, and that to affect that purpose - a sale of the greater part, if not the whole of the Real Estate of said Jacob Flook of Ind. will be required.

In tender Consideration whereof, and for as much as your Complainant is remediless in the premises by the strict rules of the Common law, & only relievable in a Court of Equity - where matters of such nature - are properly Cognizable, and to the end, that the whole of the Real Estate whereof the said Jacob Flook of Ind. dies seized, and possessed, situate in the County & State aforesaid, or so much thereof - as may be necessary for the payment of his debts, may be sold, under the Decree of this Court and that your Complainant may have all such other & further relief, in the premises as the nature and Equity of his case may require - and to the end that the adult defendants residing in the State of Maryland - may upon their several Corporal Oaths answer the several matters, and things charged in this bill of Complaint, and that the Infant defendants, by their guardian, and on the Oath of their guardian may answer this bill of Complaint.

May it please your Honor to grant to your Complainant an Order of Publication giving notice to Henry Jarboe, and Eveline E. Jarboe his wife the non resident defendants of the substance, and object of this Bill and warning them to appear in this Court in person, or by Solicitor on or before a certain day, and show cause if any they have why a Decree ought not to pass as prayed, and also a writ of Subpoena against John H. Flook, and Elizabeth Flook his wife of Washington County - also a writ of Subpoena against Daniel B. Flook & Elizabeth Flook his wife Dewalt Williams & Elizabeth Williams his wife, Jacob C. Flook, and Susan Flook his wife, Joshua Roushars & Catharine Roushars his wife, John Philip Flook, Lydia Flook, Dawson Flook, Howard Flook, Josiah Flook, Margaret Flook, and Jacob C. Flook administrator of Jacob Flook of Ind. of Frederick County State of Maryland directed to the Sheriff of Frederick County - Commanding them to appear in this Court at some certain day to be therein named to answer the premises and also by, and perform such Decree as may be passed therein, and your Complainant will ever pray &c
