 the premises until it is sold. as hereunto after directed and I further
 bequeath to her the sum of two hundred dollars. to be paid out of
 the first money coming into the hands of any executor.

Item 2^d. I give and bequeath to my daughter Mary Fulton three hun-
 dred dollars. Item 3^d. To Levitta Margaret, Melanethon & William-
 Valentine, children of my daughter Margaret Valentine dec'd. I be-
 queath three hundred dollars. to be equally divided between them.
 share & share alike. Item 4th To my grand daughter Margaret
 Valentine - I give a Bed. bedding and curtain & Bedstead.

Item 5th I appropriate thirty dollars for the payment of a note of
 hand to my son Joseph in which I am security for George Hom-
 erick. Item 6th To my daughter Catherine Homerick - I give what-
 ever amount my sons Joseph & John Smith may think proper to
 allow her. out of the estate. Item 7th It is my wish. that any ex-
 ecutor. should provide for the support of my daughter Julia out
 of my estate. in the manner he may think best. Item 8th I give
 my own Bedstead. Bed. and Bedding to my grand daughter Mary
 daughter of John Smith. Item 9th the residue of my estate. after pay-
 ing the above legacies. I give to my two sons Joseph & John to be equally
 divided between them. Item 10th my executor is hereby authorized
 to make sale of all my personal property. not otherwise disposed of
 and at a period as early as circumstances will justify he. my
 executor is hereby authorized. and empowered to sell and convey away
 all my Real estate. upon such terms as he may think best. And
 lastly I do hereby constitute. and appoint my son Joseph Smith
 to be sole executor of this my last will & Testament. revoking and
 annulling all former wills by me made. ratifying & confirming this
 and none other to be my last will & Testament. In Testimony
 whereof I have hereunto set my hand and affixed my seal. this
 20th day of June in the year of our Lord one thousand eight hundred
