

I have selected, and filed in Court here, the following Bill of Complaint and Exhibits to wit:

To the Honorable Mason Nelson Circuit Judge of the Court of Equity, for Frederick County, setting in Equity. The Bill of Complaint of William Beall, and Annie Beall his wife of Frederick County, in the State of Maryland, most Respectfully states - That some time in and about the year Eighteen Hundred and Fifteen - a certain Daniel House late of Frederick County - departed this life intestate - in said County seized and possessed of certain Real Estate, in said County, as fully described in the Copy of the Deed herewith exhibited, marked Exhibit A, which said exhibit, together with all other exhibits, hereto after filed - your Complainers pray may be taken, and considered as part of this their Bill of Complaint. Your Complainers further state - that the said Daniel House, at the time of his death - left the following children and grand children his heirs at Law, his surviving viz! John House - a son. Mary House - a daughter. Rachel House a daughter married to James Easton. William House a son. Levi House a son. Andrew House a son. Nelson House a son, Annie House a daughter, one of your Complainers. Married to William Beall Sarah House a daughter married to James E. Wood. Rebecca House a daughter married to Thomas Boyer, and Meranda House a daughter - married to Daniel Walker. Your Complainers further state, that John House the son is now dead - leaving a daughter Elizabeth House - married to Henry Hamman - John House a son, and Mahala House a daughter - your Complainers further state - That Rachel Easton, Levi House, Sarah Wood, and Rebecca Boyer the children of the said Daniel House - are all now dead. Your Complainers further state that the said Rachel Easton - left the following children: Daniel Easton, George W. Easton, and Sarah Ann Easton - married to Samuel Miller, all of whom are of the full age of Twenty one years, and residents of Frederick County - Your Complainers further state that Sarah Wood, left the following children Washington Wood, Oliver Wood, Mary Amanda Wood, Joseph E Wood Ann Sallaw and Columbus Wood, all residents of Frederick County, and of the full age of Twenty one years, except Oliver Joseph, Mary Amanda Ann Sallaw and Columbus who are infants, your Complainers further state that Levi House, the son of the said Daniel House died in the State of Ohio some time since, and that another son Nelson House, left the State of Ohio some fifteen years ago, and has not been heard of since that period, and that he has one child a minor - your Complainers further state that all of the said heirs at Law of Daniel House, reside in Frederick County - save, and except Henry Hamman & Elizabeth Hamman his wife, John House, and Mahala House children of - John House &c? / Mary House, Daniel Walker & Meranda Walker - his wife, and the infant son of Nelson House, who are now residents of the State of Maryland - your Complainers further state that the Interest, and advantage of all parties concerned, in the premises, infants, as well as adults require that the Real Estate wherof Daniel House was seized as aforesaid should be sold, under a
