} Be it remembered that heretofore, to wit, on the 27th
day of October in the year eighteen hundred and fifty
six. Came the said Ezra M. Thomas in the Court here
sitting by M^r J. Prof. solicitor and filed in court here
the following Bill and Exhibits:

Bill

To the Honorable Madison Nelson Circuit Judge for the third Judicial Circuit of the State of Maryland, - The bill of complaint of Ezra M. Thomas of Frederick County and State of Maryland who does in behalf of himself and all other creditors of S^r. Lloyd Dorsey late of said County and State deceased, who may come in and contribute to the expenses of this suit respectfully sheweth, That said Lloyd Dorsey was in his lifetime indebted to your complainant in the sum of one hundred and thirty nine dollars, as will appear by his due bill herewith exhibited marked Exhibit No 1 which Exhibit together with all other Exhibits hereinafter produced your complainant prays may be taken as a part of this his Bill of Complaint, Your complainant further states that said Lloyd Dorsey died intestate in the month of September eighteen hundred and fifty six. Seized and possessed in fee of a house and lot on Market Street, Frederick, Maryland, which is more fully and at large described in the Copy of the deed herewith exhibited marked Exhibit No 2, Your complainant further states that the said Lloyd Dorsey left a widow named Rebecca Ann Law Dorsey, and the following children as his heirs at law to wit, Virginia Lawrence Dorsey, Nicholas James Lloyd Dorsey, Drusilla Dorsey, William Nevins Dorsey, Rachel who married John Trafford, That all of the said Children are of full age except William Nevins Dorsey who is an infant under the age of twenty one, that Virginia, Drusilla and William Nevins Dorsey reside in Frederick County, that Lloyd Dorsey resides in the City of Baltimore, that Nicholas J. Dorsey resides in the State of Indiana, and that John Trafford and Rachel Trafford his wife reside in the State of New Jersey, Your complainant further states that the said Lloyd Dorsey being indebted by bond in the penalty of four thousand dollars conditioned for the payment of two thousand dollars with interest from the first day of June eighteen hundred and fifty two, to Franklin Myers then and now an infant under the age of twenty one years on the nineteenth day of August in the year eighteen hundred and fifty two, in conjunction with his wife Rebecca Ann Law Dorsey executed a Mortgage of land herebefore described real estate to said Franklin Myers to secure the payment of the said sum of two thousand dollars which sum is still due and unpaid all of which matters will more fully appear by reference to a certified Copy of said deed of Mortgage herewith exhibited marked Exhibit No 3, Your complainant further states that the said Lloyd Dorsey died intestate and that George Smith of Frederick County was duly appointed by the Orphans Court for Frederick
