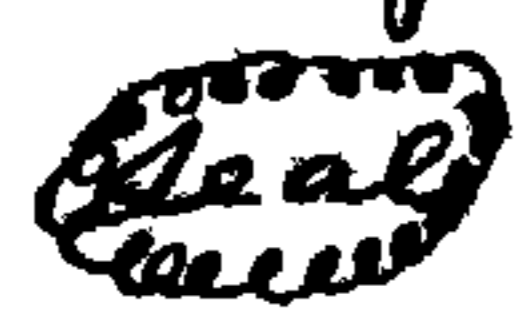

This Indenture, made this 24th day of June 1852 between George J. Fischer & Isabella Fischer his wife, of the County of Frederick and State of Maryland of the one part and Michael Keefer, A. B. Hanson, and Jacob Markell of the County and State aforesaid of the other part, Whereas the said George J. Fischer by his certain promissory note bearing date the 9th day of June 1852 and payable four months after the date thereof to John H. Williams Cashier, or order promised to pay to John H. Williams, Cashier or order the sum of five hundred dollars for value received & whereas the said George J. Fischer by his certain other promissory note bearing date the 21st day of May 1852 promised six months after date to pay to Lewis Ramsburg, Secretary or order one thousand dollars for value received, and whereas
