

in the year of our Lord 1839 before the subscribers two Justices of the peace
of the State of Maryland in and for the City of Baltimore aforesaid

they being known to us to be the persons who are named and described
as and professing to be the parties of the first part to the aforesaid
Indenture or Instrument of writing and personally acknowledged the
same to be their respective act and deed the said Margaret Patterson
having signed & sealed said indenture and made her said acknow-
ledgement thereof before us out of the presence & hearing of her said
husband and the said Margaret Patterson being by us privately exam-
ined out of the presence and hearing of her husband declared & said

and without being induced to do so by fear or threats of or all usage
