

the term of her natural life in half yearly payments And from and immediately after her decease the principal shall revert to my estate and be considered as a part of the rest and residue thereof I give and bequeath to each one of my three sons Samuel S Moyers William R Moyers and Charles H Moyers one and above their respective proportions of the residue of my estate the sum of \$5000 - apiece to be paid to them at the option of my Executors hereinafter named either when and as my said three sons respectively attain the age of 21 years or 25 years But if the payment of said legacies of either of them should be withheld to the latter age then I order and direct that the interest on the legacy or legacies so withheld shall be paid to him or them entitled thereto after he or they shall have attained the age of 21 years I order and direct that all sums of money or other property charged to any of my children in my account book marked A. shall be brought into view in the settlement of my estate and constitute a part of the same and be deducted from the portion or share of him or her so charged. Item all the rest residue and remainder of my estate real personal and mixed of every kind and description without reservation or exception I order and direct shall be divided into ten equal parts or shares which I desire and dispose of in manner following that is to say one tenth part thereof to my said son Samuel S Moyers his heirs Executors Administrators and assigns forever one other tenth part thereof to my said son William R Moyers his heirs Executors Administrators and assigns forever one other tenth part thereof to my said son Charles H Moyers his heirs Executors Administrators and assigns forever \$10,000 out of each one of the remaining seven ~~parts~~ ^{parts} making together the sum of \$70,000 in stocks or in cash to be vested in real estate or stocks or placed out at interest upon good mortgage or other safe security at the discretion of my daughters Mary Williams Louisa Webb Sarah Dulves Sophia Dince Julianna Cole Rebecca A Moyers and Emily Augusta Moyers respectively I give devise & bequeath unto my son Samuel S Moyers above named and my sons in law James Williams and Joshua S Dulves and the survivors and survivor of them and the heirs Executors and Administrators of the survivor in special trust and confidence nevertheless and to for and upon the uses and trusts and to the ends intents and purposes hereinafter mentioned expressed limited and declared of and concerning the same that is to say in trust that each one of my said seven daughters Mary Williams Louisa Webb Sarah Dulves Sophia Dince Julianna Cole Rebecca A Moyers and Emily Augusta Moyers respectively be permitted and suffered during their natural lives respectively to have hold use possess and enjoy one of said sums of \$10,000 in the stocks and property in which the same may be vested and the income issues profits and interest thereof to receive take and apply to their sole and separate use and benefit respectively without being subject to the control power or disposal of their respective husbands or liable for the payment of their debts or bound for the fulfilment of their contracts or engagements and the receipts of my said seven daughters respectively alone shall be good and sufficient releases acquittances & discharges
