Hammon and Lyde Griffith and Louisa Griffith his wife Mordecai Griffith and Juliet Angel of Frederick County State of Maryland and of Rachel Hammon and Amy Hammon his wife of same County State of Maryland to the bill of Complaint of Thomas Hammon filed in the Circuit Court for Frederick County as a Court of Equity against themselves and others These defendants for answer to said Bill of Complaint answer and say that they admit that Carroll Hammon late of Frederick County State of Maryland died intestate in the month of September 1856 seized and possessed by three parts of tracts of land situated in Frederick County State of Maryland containing about one hundred and twenty four acres of land more or less heretofore conveyed to said Carroll Hammon by Rachel Hammon and by John Hammon by deed Copies of which are exhibited in said bill as Exhibits N^o 1 and N^o 2 These defendants further admit that said Carroll Hammon left at his death the following brothers and sisters and children of brothers and sisters living who are his heirs at law to wit 1st Adelia Mearns now wife of Alpheus W. Mearns a daughter of Elyzabeth Hammon now deceased a sister of said Carroll Hammon who died before her brother the said Carroll Hammon 2nd The following children of Upton Hammon a brother of said Carroll Hammon who died before said Carroll Hammon to wit Harriet now wife of Benjamin Todd Martha now wife of Ephraim Richmond Philip Hammon Rachel Hammon and Upton J. Hammon 3rd The following children of Nathan Hammon a brother of said Carroll Hammon and who died before said Carroll Hammon to wit Washington Hammon William Hammon Burgess Hammon Richard J. Hammon Carroll Hammon Nathan Hammon Charlotte now wife of Basil Wood Louisa now wife of Lyde Griffith & Margaret who married Mordecai Griffith and who died in the month of February 1857 after the said Carroll Hammon leaving two children his heirs at law to wit Anna Mary Griffith and Byron Griffith 4th A brother named Rezin Hammon 5th a brother named Thomas Hammon the complainant in this cause 6th a sister named Juliet who married Jacob Angel and who survives her said husband
