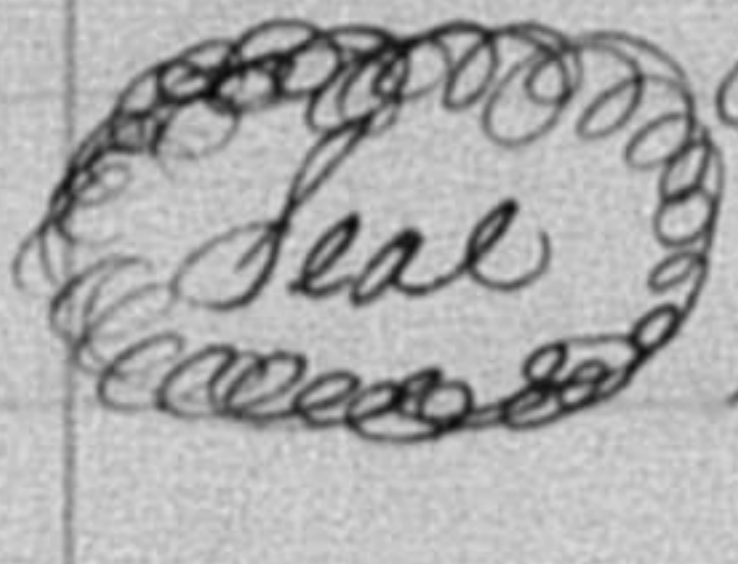

At the request of John Stine the following Deed was recorded May 28th 1862.

This Indenture made this 13th day of August in the year of our Lord one thousand eight hundred and forty nine, between Peter Groppnickel and Hannah Groppnickel his wife of Frederick County in the State of Maryland of the one part, and John Stine of the County and State aforesaid of the other part, Witnesseth that the said Peter Groppnickel and Hannah his wife, for and in consideration of the sum of five hundred and forty one dollars current money of the United States to them in hand paid by the said John Stine before the sealing and delivery of these presents the receipt whereof they the said Peter Groppnickel and Hannah his wife, do hereby acknowledge have granted, bargained, sold, aliened, enfeoffed and confirmed and by these presents do grant, bargain, sell, alien, enfeoff and confirm unto the said John Stine his heirs and assigns forever all the following described lots pieces or parcels of land lying and being in the County and State aforesaid being part of a tract of land called "Murdock's Mountain Resurvey" to wit - Lot Number four and part of Lot No 8 lying contiguous to each other and together contained within the courses and distances metes and bounds following viz beginning for the said Lot No 8 and part of the said Lot No 8 as now included within one general outline at the end of the second line of a tract of land called "Calf Pasture" it also being the end of the fourth line of the whole Lot No 8 and running thence with the lines of said whole Lot reversed six courses and distances viz - S 25 degis E 34 ft. S 46° E 36 ft. S 72° W 11 1/4 ft. to the end of the fifth line of Lot No 7, S 12° W 50 ft. to the beginning of a tract of land called "Cow pasture" and with said land reversed S 3° E 14 ft., S 7 1/2° W 34 ft. to the end of the 5th line of the said lot No 4, then with the lines thereof seven courses and distances S 41° W 40 ft. S 53 ft. W 67 3/4 ft. to the 3rd line of 39 acres deeded by the said Peter Groppnickel to Peter Boyer the 20th of April 1833, then with said 3rd line N 27° W 18 ft. to the end thereof still N 11° E 60 ft. to the beginning of Lot No 4, W 26 ft. to the end of the 2nd line of Lot No 3 and with the 3rd line thereof N 21 degis E 92 ft. to the end of 17 1/2 ft. on the 64th line of the whole tract called "Murdock's Mountain Resurvey" then with said line reverses S 77° E 17 1/2 ft. to the end of the 12th line of Lot No 8 aforesaid then with said whole lot No 8, reversed two courses and distances viz North 37° E 40 ft. S 80° E 20 ft. then by a straight line to the place of beginning containing one hundred and five and a quarter acres more or less, also lots No 1 and 2, in the North tier of lots in Hamburg, Beginning to include the said lots No 1 and No 2, in one outline at a stone planted in the 181st line of the whole tract called "Murdock's Mountain Resurvey" being at the end of 70 perches reversed from the end of said line and running thence with said 181st reversed S 5° W 20 ft. to the North side of the Street or road leading through Hamburg then by and with the North margin of the said Street W 84 feet then N 20 ft. to intersect the Northern line of the Northern tier of the lots aforesaid then by and with said Northern line to the place of beginning, Together with all and singular the buildings improvements, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining and the reversions and remainders, rents, issues and profits thereof and all the Estate right, title and interest whatsoever of them the said Peter Groppnickel and Hannah his wife, both at law and Equity of, in to and out of the said lots or parcels of land and premises hereby -
