Letters of Guardianship

State of Minnesota, County of Ramsey, S. D.  
The Probate Court of Ramsey County, In David Cooper Executor; Whereas, an application in due form of law has been made to the Probate Court, to have you, the said David Cooper appointed the Guardian of the person and estates of Eleanor Munn Cooper a minor, residing in the County of Ramsey under the age of fourteen years; and whereas you have agreed and consented to become such Guardian, and have duly executed and delivered a bond, pursuant to law, conditioned for the faithful performance of your duties as such Guardian; and the Court being satisfied of the sufficiency of such bond, and that you are a good and reputable person, and are in every respect competent to have the custody of the person and Estate of said minor, does by these presents, allow constitute and appoint you, the said David Cooper the Guardian of the person and Estate of said minor, during her minority, with full power to demand, sue for, and take possession of all money and estate belonging to said minor, hereby requiring you, the said Guardian, to safely keep the real and personal estate of said minor, which shall hereafter come to your custody, and not suffer any waste, sale or destruction of the same, but to keep up and sustain her lands, tenements and hereditaments, by and with the rents issues and profits thereof, or with such other moneys belonging to her as shall come to your possession, and to deliver the same to her when she becomes of age, or to such other Guardian as may be hereafter appointed in as good order and condition as you received the same; and also, to render a just & true account of all moneys and property secured by you, and the application thereof, and of your Guardianship in all respects, to any Court having cognizance thereof, when the same is required, and in general to do all acts which appertain to you in said capacity, and as the law shall charge you.
