Lambert Judge of Probate in and for said County or to his successors in Office, in the sum of one thousand dollars, lawful money of the United States, to be paid to the said Judge of Probate or his successors in Office to which payment well and truly to be made, we bind ourselves, our and each of our heirs Executors and administrators, jointly and severally firmly by these presents, sealed with our seals and dated at Saint Paul Ramsey County Minnesota, this 26th day of March A.D. 1864.

The condition of this obligation is such, that if the above bounden David Cooper shall and will faithfully in all things discharge the duty of Guardian to the said minor Eleanor Minne Cooper and will make a true inventory of all the Estate real and personal, of his ward, that shall come to his knowledge and to return the same unto the Probate Court of this County within three months or such time as the Judge of said Court may order; will dispose of and manage all such Estate according to law, and for the best interest of the ward; and will faithfully discharge his trust in relation thereto and also in relation to the care custody and education of the ward; will render an account in oath of the property, Estate and money of the said ward in his hands and all proceeds or interest derived therefrom, and of the management and disposition of the same within one year after his appointment and at such other times as the Court shall direct; and will at the expiration of his trust settle her account with the Judge of Probate or with the ward if she is of full age or her legal representatives and pay over and deliver all the estate, money and effects remaining in his hands or due from him in such settlement to the person who shall be lawfully entitled thereto, and to do and perform all things according to law, and render a true and just account of all money and property received by him and of the application thereof, and of his Guardianship, in all respects, to any Court having cognizance thereof when thereunto required then this obligation to be void, else to remain in full force and virtue.
