3^d Did the said Magdelina Jensenbaugh die seized and possessed of any real estate, if yes describe the same as near as you can.
4th Did the said Magdelina have a will?
5th Did the said Magdelina have any heirs, if yes, name them and state which of them are adults and which of them are infants under twenty one years of age.
6th Is the real estate mentioned in these proceedings, of which the said Magdelina died seized and possessed, capable of an advantageous division, if not would it not be to the advantage of all the parties to this suit that the same should be sold and the proceeds divided amongst said parties.
