

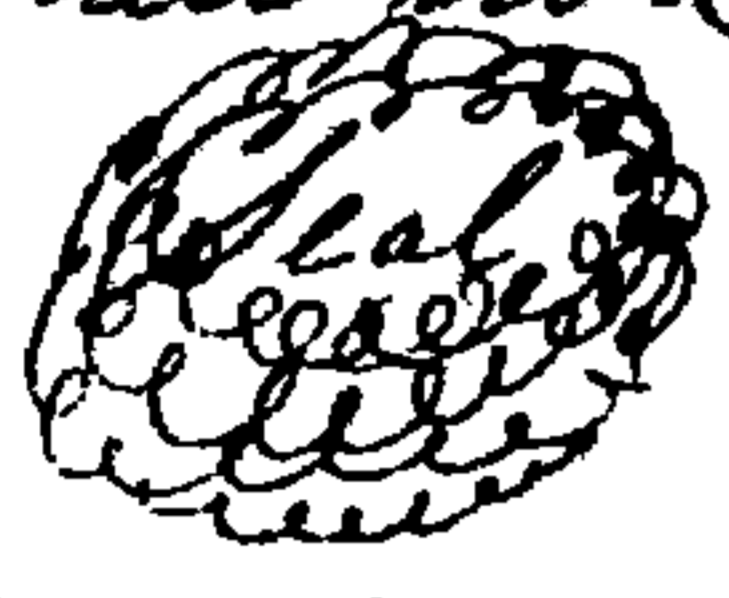

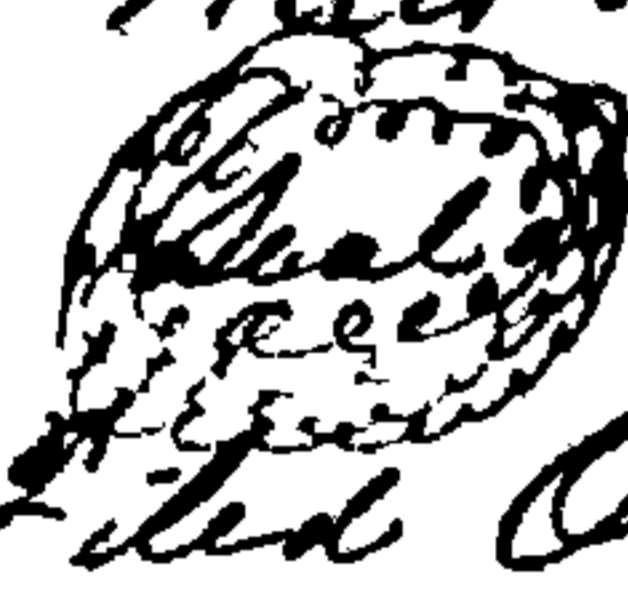

Extract from the Last Will and Testament of Charles A. Griffiths late of Frederick County deceased, executed on the 9th day of May 1863, and probated on the 11th day of November 1863 Item First, I give and bequeath to my nephew Berow A. Griffiths, the son of my Brother Mordecai J. Griffiths deceased, one half of my Real Estate, also one half of my personal estate. Item Second, I give and bequeath to my niece Anna Mary Griffiths daughter of my Brother Mordecai J. Griffiths deceased, the other half of my Real and Personal property.

At the request of Mordecai J. Griffiths the following Deed was recorded December 9th 1857 -

This Indenture made this first day of December in the year of our Lord one thousand eight hundred and fifty one, between John A. Griffiths of Frederick County in the State of Maryland of the one part and Mordecai J. Griffiths of the County and State aforesaid of the other part, Witnesseth, that the said John A. Griffiths for and in consideration of the sum of Four Hundred and fifty Dollars, current money, to him in hand paid by the said Mordecai J. Griffiths before the sealing and delivery of these presents the receipt whereof he the said John A. Griffiths doth hereby acknowledge and from every part and parcel thereof doth hereby acquit exonerate and discharge the said Mordecai J. Griffiths his heirs, executors, administrators, he the said John A. Griffiths hath granted, bargained, sold, aliened, infeoffed and confirmed, and by these presents, doth grant bargain, sell, alien, infeoff and confirm unto the said Mordecai J. Griffiths his heirs and assigns, all my right title, interest of, in and to all the real estate bequeathed to me by my Grand father Philemon Griffiths dec^d as by reference to his last will and testament dated the thirteenth day of December Eighteen hundred and thirty seven, will more fully appear; together with all and singular the buildings improvements rights, liberties, privileges and appurtenances whatsoever thereunto belonging, or in any wise appertaining to him the said Mordecai J. Griffiths his heirs and assigns forever. In Witness whereof the said John A. Griffiths hath hereunto subscribed his name, and affixed his seal the day and year hereun before written.
