 land now held & owned by my brother & myself shall be
 sold & out of the proceeds I desire & bequeath to Peter
 Pissner the sum of fifty hundred dollars to Rebecca Abough
 wife of Valentine Abough the sum of two hundred dollars
 to Rhoda wife of Peter Abough the sum of two hundred dollars
 to Christian Neighboof the sum of two hundred dollars to Susan
 Britson wife of John Britson the sum of two hundred dollars
 to Zabeel Neighboof the sum of two hundred dollars to the
 Jeffersons & Friends Benevolent Society of the Methodist-Protes-
 tant Church the sum of five thousand dollars in trust
 to invest the same & apply the income to the support of the
 Home Mission of the Methodist-Protestant Church within
 the bounds of the Maryland District and to the Pipe
 Creek Benevolent Society the residue of my interest in the
 proceeds of the sale of said land in trust for the same
 purpose and by her Codicil to said will bequeathed
 some other legacies to be paid out of said proceeds of
 the sale of said real estate after the death of her said
 brother Stephen as will fully appear by reference to said
 last will & testament & Codicil true & Certified Copies
 whereof are filed as exhibits Nos 223 in N^o 2799 Equity
 in your Honorable Court which with all the proce-
 dings therein your petitioners pray may be taken as a
 part of this petition as if here inserted in words and
 figures & our petitioners further shew that said Susan
 Ransburg soon after departed this life seized of a valuable
 real estate as tenant in common with her brother
 Stephen & without having in any manner revoked or
 altered her said will & Codicil & that since her death
 a bill has been filed in your Honor Court by said Stephen
 Ransburg & after due proceeding therein a decree has
 been made by the sale of said real estate that said
 real estate has been sold & the funds brought into
 your Honor Court for distributions as will appear by the
