

At the request of Andrew Draper & others the following  
 Deed was recorded October 5th 1824 to wit  
 This Indenture made the eighteenth day of May in the year  
 one thousand eight hundred and twenty four between John  
 Wisman Junr. of Frederick County and state of Maryland of the  
 one part, and Andrew Draper William Draper Elizabeth Draper  
 Hopewell Draper Nancy Draper Isaac Draper David Draper Daniel  
 Draper and Joseph Draper of same place of the other part -  
 Witnesseth that the said John Wisman Junr for and in consid-  
 eration of two hundred dollars Current money to him in  
 hand paid before the sealing and delivery of these presents  
 the receipt whereof by the said John Wisman Junr doth  
 hereby acknowledge hath granted bargained sold aliened  
 released, released and Confirmed and by these presents doth  
 grant bargain sell alien release release and Confirm unto  
 them the said Andrew William Elizabeth Hopewell Nancy  
 Isaac Dana Daniel & Joseph Draper their heirs & assigns  
 forever all the right title and interest whatsoever of him  
 the said John Wisman Junr in and to all that part of a  
 tract of land in the County aforesaid being part of a tract  
 called The Range about the Miserable Nobs which was hitherto  
 conveyed by Wm. McBeane Sheriff to Abraham Loms and afterwards  
 by Abraham Loms to the said John Wisman Junr. Beginning  
 at the original beginning of the whole tract called The Range  
 about the Miserable Nobs and running thence by and with the  
 outlines thereof by Course North 75 degs East 60 ps North 40 degs  
 West 72 ps South 52 degs West 52 ps North 8 deg West 80 ps -  
 North 51 deg West 30 ps North 10 deg West 24 ps to a large  
 post driven in the ground then South 76 1/2 degs East 138 ps  
 to a stone near a black Oak Sapling marked with six notches  
 South 43 1/2 degs East 97 perches to a stone planted by the side  
 of a large locust post driven in the ground standing at the end  
 of the 66th line of a tract called "Lots claim Enlarged" then  
 by and with the outlines thereof South 42 degs West 20 ps  
 North 38 deg West 20 ps South 23 deg West 16 ps South 62 degs  
 East 10 ps South 34 deg West 6 ps North 18 deg West 12 ps North  
 53 deg West 5 ps South 42 deg West 32 ps South 74 deg West 4 ps  
 then with a straight line to the beginning containing ninety  
 three and one quarter acres of land together with the  
 rights members and appurtenances thereto belonging or in  
 any wise appertaining and the revenues and remainings  
 remainders and remainders rents issues and profits thereof  
 and all the estate right title interest property claim and  
 demand whatever legal and equitable of him the said  
 John Wisman Junr in and to the said land and  
 premises hereby bargained and sold with the rights  
 members and appurtenances and any or any part or  
 parcel thereof. I have and to hold the said land  
 and premises hereby bargained and sold or meant  
 mentioned or intended hereby to be and any or any
