At the request of Andrew Draper the following Deed  
 is recorded the 31st day of March 1841  
 This Indenture made the second day of March in the year  
 1841 between David Wolfe Junr of Frederick County & State  
 of Maryland of the one part and Andrew Draper of the  
 County and State aforesaid of the other part. Whereas by an  
 order of John Hamly one of the Justices of the Orphan Court  
 of Frederick County the above named David Wolfe Junr was  
 appointed Auditor under the Insolvent Laws of 1805 and the  
 several Supplements thereto to sell for Cash all the estate right  
 and title of Isaac Draper and convey the same to the  
 purchaser or purchasers thereof that in pursuance of the said  
 order the said David Wolfe Junr as Auditor as aforesaid  
 did on the 10th day of October 1840 sell & dispose of to the above  
 named Andrew Draper all the right title and interest of the  
 said Isaac Draper of in and to part of a tract of land  
 called The Range about the Three Miserable Jobs and  
 containing nearly three & one quarter acres of land lying  
 and being in the County and State aforesaid at and for  
 the sum of fifteen dollars current money and whereas the  
 purchase money for the said part of a tract of land and  
 premises hath been fully paid and satisfied and the  
 said David Wolfe is authorized by said order to execute  
 a conveyance for the same and to comply with the terms  
 of said order the said David Wolfe Junr hath agreed to  
 execute these presents. Now this Indenture Witnesseth that  
 the said David Wolfe Junr in consideration of the above  
 recited premises and also of one dollar current money  
 to him in hand paid by the said Andrew Draper the receipt  
 whereof is hereby acknowledged hath granted bargained and  
 sold released infeoffed and confirmed and by these  
 presents doth grant bargain sell release infeoff and confirm  
 unto the said Andrew Draper his heirs and assigns from  
 all the aforesaid right title and interest in and to the  
 said part of a tract of land and premises with the  
 appurtenances thereto belonging or in anywise appertain  
 ing unto him the said Andrew Draper his heirs or assigns
