I give & bequeath unto my five Grand Children the Children the Children of my son Daniel House who is now dead and having five Children by a second wife to wit Nelson House Anna House Sarah House Rebekah House and Marandah House my Will is that my Executors hereafter named pay to each of them as they arrive to the age of Majority three hundred Dollars Current money of the United States to be paid from my surplus property & ear of interest thereon. I give and devise unto my oldest son George House of Hydencks County one hundred acres of land to be laid off by my Executors hereafter named to be laid off when he now lives or as not to injure my home place and my Executors after they lay it off are fully empowered to make him a deed for the same if he requests them without a Deed from them his Children shall not inherit this is to be considered to be his full share of my estate as he managed at 19 years of age and left me & had ever since to work for himself. I give & devise unto my son Calif House one hundred acres of Land including what I gave him lately by deed of gift to be laid off by my Executors hereafter named and they are fully empowered to deed the same if requested until then him or his heirs cannot inherit this to be considered his full portion of my estate as he has very much displeased me by consanguinity with my daughter Nancy to deprive me of part of my valuable Land as they have taken advantage of me by my giving her the said Nancy Hawley a deed for it not doubting but I was to have the use of it the short time I may have to live but it seems I must do without it & they may make the most of it.
