 This Indenture made this 12th day of May in the year of Our  
 Lord one thousand eight hundred and forty eight between James  
 Jacobs and Adam Jacobs of Frederick County in the State of Maryland  
 Executors of the last will and testament of Adam Jacobs late of  
 Frederick County deceased of the one part and aya Sarah Jacobs  
 of the same County and State aforesaid of the other part -  
 Witnesseth that Whereas the said Adam Jacobs deceased  
 by his last will and testament bearing date on the 25th day  
 of September A. D. 1817 and recorded in the office of the Register  
 of Wills in Frederick County aforesaid as well by reference  
 thereto being had and authorize and empower James Jacobs  
 and Adam Jacobs his Executors to dispose of and convey his  
 estate for the purposes expressed in his said will Now this  
 Indenture Witnesseth Witnesseth that the said James Jacobs  
 and Adam Jacobs Executors as aforesaid as well by virtue  
 of the power and authority to them given as aforesaid as in  
 consideration of the sum of three hundred dollars Current Money  
 to them or here paid or secured to be paid by the said David  
 Jacobs the receipt whereof they the said James Jacobs and Adam  
 Jacobs Executors as aforesaid do hereby acknowledge have granted  
 bargained and sold and do hereby grant bargain and sell  
 convey and confirm in said Capacity unto the said  
 David Jacobs his heirs & assigns forever all of that tract or parcel  
 of land called Middle Plantation which is contained within
