 secured to my beloved wife Rebecca L. Deise my house and
 lot of ground upon which we now reside to land as the remains
 my wife should she marry again or die then said house
 and lot of ground to become the property of my daughter
 Susannah H. Stoner and her heirs I also give and bequeath to my
 wife on the same terms my clock I also give and bequeath to my
 wife for herself and her heirs Twenty eight Dollars in Cash also
 all the personal property that she possess when we were married
 with my bestead and bedding and furniture tubs barrels and
 their contents and it is further my will that my wife shall be
 furnished annually from the proceeds of my farm with 15 bushels
 wheat twenty bushels Corn and five cords of wood the wood
 to be delivered at her house and pasture for two cows It is also
 my will that my wife shall have as much bacon and lard as
 will suffice for her family until the season for killing up meat of that
 kind shall arise also any sheets that I may have at the time of my
 decease not exceeding three in number to be the property of my wife
 also all the hay fodder &c intermed for my use shall remain for the
 benefit of my wife should it be the desire of my wife at any time
 to remove from the house & let my executor shall sell or quit the
 same to the best advantage and pay over to my wife the interest of the
 amount of such sale or the rent for the Cash may be should
 my wife marry again then the wheat Corn fire wood & Corn pasture
 to be given to her annually shall cease altogether This I
 give and bequeath to my daughter Susannah H. Stoner and her heirs
 the farm upon which she and her husband and family now
 reside as well as all other property of whatever kind it may
 be that I may be in possession of at the time of my decease
 not otherwise herein disposed of for the benefit of herself and her
 heirs If my daughter Susannah H. Stoner should at any time
 desire to change her location it is my will that she dispose of her
 present home to the best advantage and invest the proceeds of
 such sale in some other real estate for herself and her heirs
 I hereby empower my executor to execute to Fott & Partners
 a good and sufficient deed for the farm purchased from one
 upon his first having fully complied with the terms of purchase
 Fifthly at the decease of my wife any necessary expenses respecting
 her funeral to be paid by my executor Lastly I constitute and
 appoint Augustus Stoner and John Finzer Executors of this
 Testament and do hereby ratify and confirm the same as such
