 Ordered by the Court this 29th day of May 1862 that William
 L. Poppe as trustee be directed to pay over to the creditor of John
 McPherson of the sum paid by Bradley J. Johnson and George R.
 Shullman the former trustee together with a due proportion
 of interest by him received as ascertained and distributed
 by the audit made in this case deducting the taxed
 costs of said audit made and ratified his expenses
 for Copies of Deeds and a fee of forty dollars to said William
 L. Poppe trustee for his services in collecting and disbursing said
 trust funds

 and a resident of Frederick County her children and heirs at Law
