Lot No. 7 Part of "Altogether" Beginning at a stake & pile of stones at the end of 2<sup>nd</sup> line of the deed from Joshua Johnson to Benjamin Johnson dated 29<sup>th</sup> December 1830 for 231 1/4<sup>ac</sup> running thence with lines of said deed 2 courses & distances with such allowance for variation necessary to agree with former running S. 22 1/2° N. 58 ps to stake & stones S. 68 1/2° E. 22 ps to stake and stones where a chestnut tree formerly stood then S. 66° E. 59 1/2 ps to stake & stones in the 5<sup>th</sup> line of Lot No. 1 then with said 5<sup>th</sup> line reversed N. 11 1/2° E. 43 1/2 ps to stake & pile of stones at the end of the 4<sup>th</sup> line of said Lot No. 1. it also being in the 2<sup>nd</sup> line of the 201 3/4<sup>ac</sup> dead aforesaid then with said 2<sup>nd</sup> line allowing for variation as aforesaid N. 52 1/2° W. 78 ps to the place of Beginning containing 23 1/2 a.

Lot No. 9 Part of "Altogether" Beginning at stake & pile of stones at the end of 3<sup>rd</sup> line of Lot No. 8, it also being in the 5<sup>th</sup> line of the deed from Joshua Johnson to Benj Johnson dated 29<sup>th</sup> Dec<sup>r</sup> 1830 for 231 1/4<sup>ac</sup> running thence with the 3<sup>rd</sup> line of Lot No. 8 aforesaid, S. 66° E. 70 1/2 ps to a stake & stones at the end of the 5<sup>th</sup> line of Lot No. 1. then with the cutting of Lot No. 1 2 courses and distances S. 17 1/2° N. 53 ps to a stake & stones N. 74 1/2° W. 32 1/2 ps to a stake & stones S. 29 1/2° W. 26 1/2 ps to a stake & stones in the south margin of the boundary leading to Hedrick City, it also being in the closing line of the 201 3/4<sup>ac</sup> dead aforesaid & at the end of 40 ps then with said closing line reversed N. 54° W. 40 1/2 ps to a stake in the stump of a black oak tree at the end of the 5<sup>th</sup> line
