May it please your Honor to order & decree that said defendants, or some one of them shall on or before a day to be named by your Honor pay and cover up \$100 with legal interest thereon from the 3rd day of February 1862, until paid and that in default thereof, the said mortgaged premises be sold by a trustee to be appointed by your Honor for that purpose and that your Honor may have all such other & further relief in the premises as the nature of the case may require & to your Honor shall seem meet; May it please your Honor to grant unto your Oration the status of Maryland and east of our Oration to be directed to the said James A. Allen & Julia Ann Allen, his wife, Henry Lyday & Charlotte Lyday his wife, John Moulder & Lelia Ella Moulder of Montgomery County, Mary Ann Handt, Dora Handt, John Handt & Minerva Druilla Handt of Frederick County there by commanding them and each of them to be and appear before your Honor in your Honorable Court to answer all & singular the premises and to stand to, abide & perform such order & decree in the premises as to your Honor shall seem meet, And your Oration will ever pray &c.
