Whereas the said John W. Ramsburg by a decree dated on the 16th day of February in the year 1863, had passed on a cause pending in the Circuit Court for Frederick County as a Court of Equity in No 2992 Equity has been appointed Trustee to complete the trusts imposed by Henry Crown the former Trustee in said cause. Now the condition of the above obligation is such, that if the above said John W. Ramsburg shall well and faithfully perform and execute the trusts imposed on him by the said decree which may be required in any future order and decree in the premises, then the above obligation shall be void otherwise to be in full force and effect in law.
