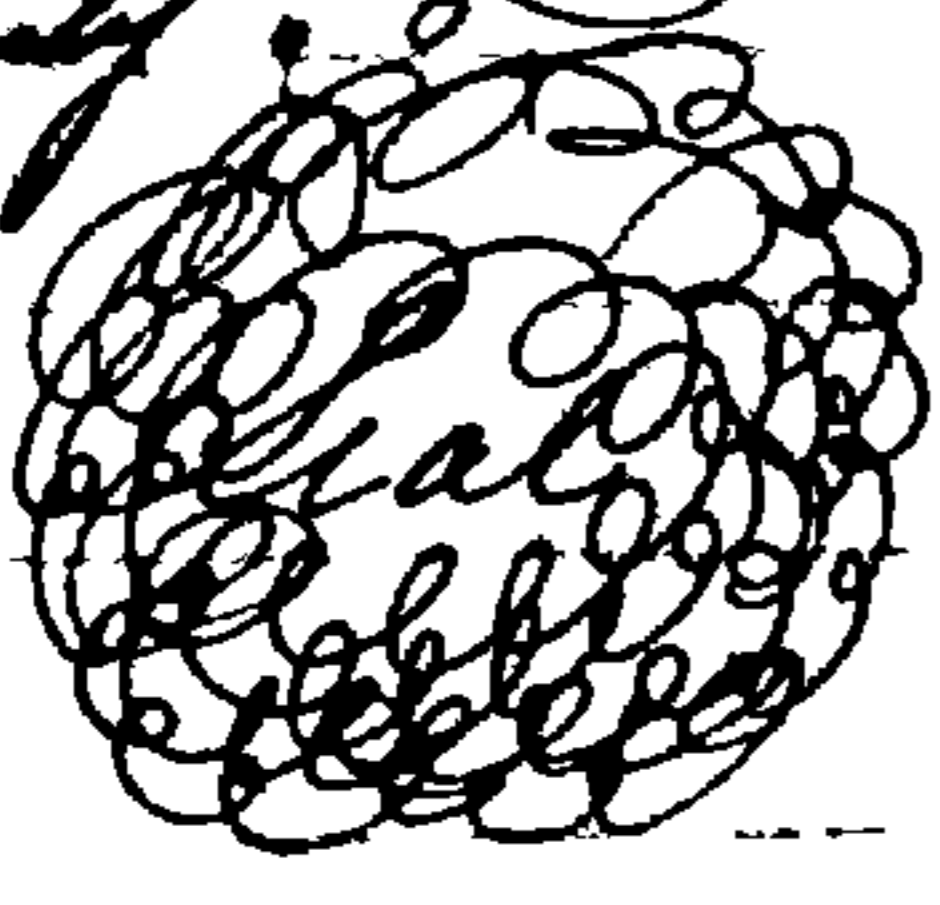

This Deed made this fourteenth day of October in the year Eighteen hundred and fifty seven by Abner Campbell and Catharine his wife of Frederick County in the State of Maryland, Witnesses, that in Consideration of the sum of Six Hundred and thirty five dollars, the said Abner Campbell, and Catharine his wife do grant unto Writhe Lowe of said County and State, all the right, title and interest, both at Law and in Equity of them the said Abner Campbell and Catharine his wife, in and to all that lot or parcels of ground, situate lying and being in East South Street in Frederick Town in said County and State, which was conveyed to the said Abner Campbell by Norman W. Harding, Sheriff of Frederick County by indenture bearing date on the thirty first day of December in the year Eighteen hundred and fifty, and duly recorded amongst the Land Records of Frederick County, on the twenty second day of September in the year Eighteen hundred and fifty two in Liber C. S. No. 2, folios 393, 394, and which is more particularly mentioned and referred to in said indenture, to which reference is hereby made, in fee simple

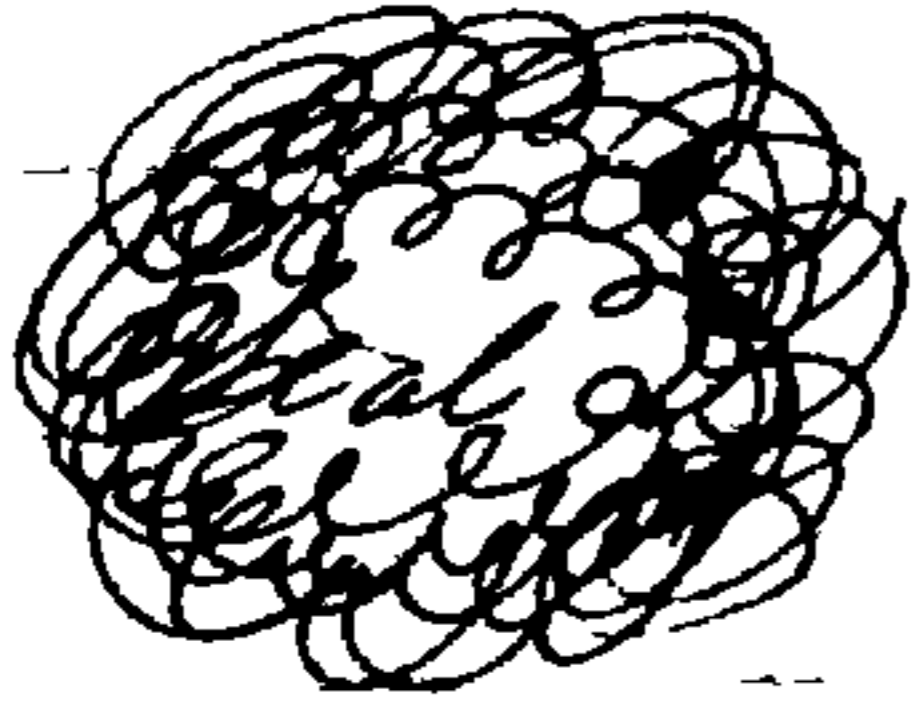

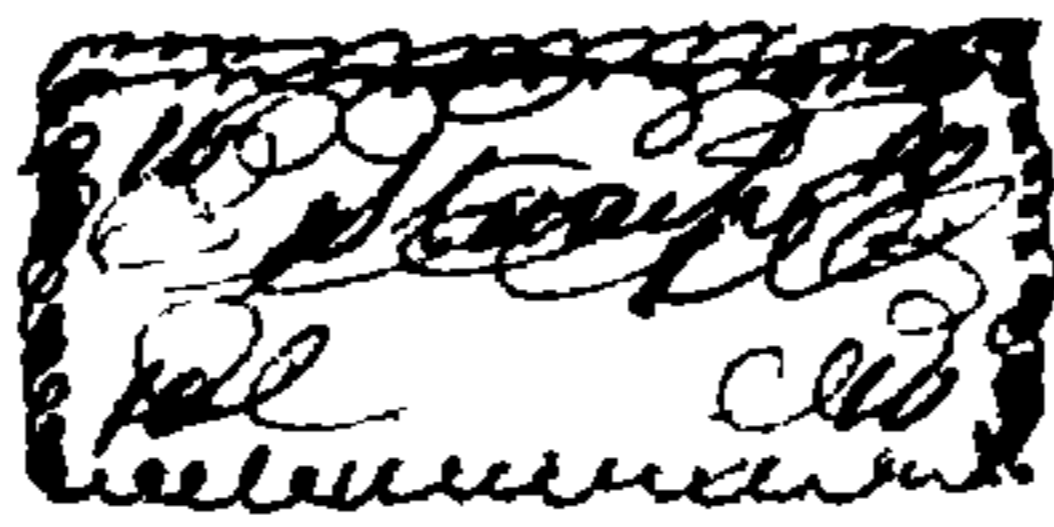
