Snyder and Clarence Snyder the sum of One hundred dollars each. ~ Item 6th, I give and bequeath to my daughter Olivia Jane Lease wife of Thomas M. Lease, the sum of Five hundred dollars. ~ Item 7, I give and bequeath to my two daughters Anna Snyder and Sarah Emma Snyder the sum of Five hundred dollars each. ~ Item 8th I give and bequeath all my Household and kitchen furniture to my said wife and my four daughters, share and share alike. ~ Item 9th I give and bequeath to my Family, and for my said Family's use and benefit my Horse Cow and Spring Wagon ~ Item 10th I devise and bequeath all the rest and residue of my Estate both Real and personal to be equally divided among all my children in equal proportions share and share alike. ~ And lastly I do hereby constitute and appoint my son Oliver P. Snyder to be sole Executor of this my last Will and Testament, revoking and annulling all former Wills by me heretofore made ratifying and confirming this and none other to be my last Will and Testament. ~
