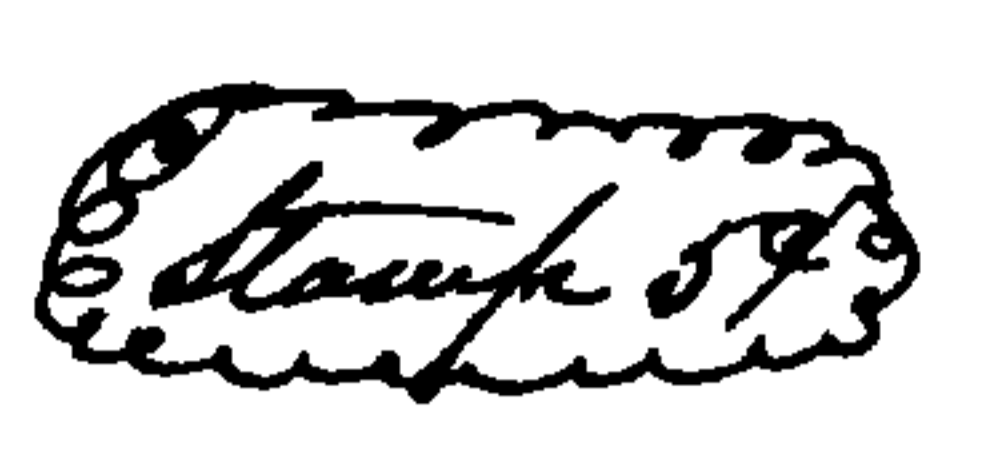

After all my just debts and funeral expenses are paid, I give, devise and bequeath as follows. ~

To my wife Mary A. Thomas, I give and devise all and any property whether real personal or mixed, which shall or may be in the hands of My Executor, after the settlement of my worldly affairs to be held, used, and controlled by her for her own use and maintenance, and especially as a sacred trust for the Education and keeping together of my younger children. ~

And I hereby appoint my friend and relative Archibald T. Snouffer, as my Executor to carry out my wishes. ~

In testimony whereof I hereunto affix my hand and seal this twenty ninth day August Eighteen Hundred and Seventy.

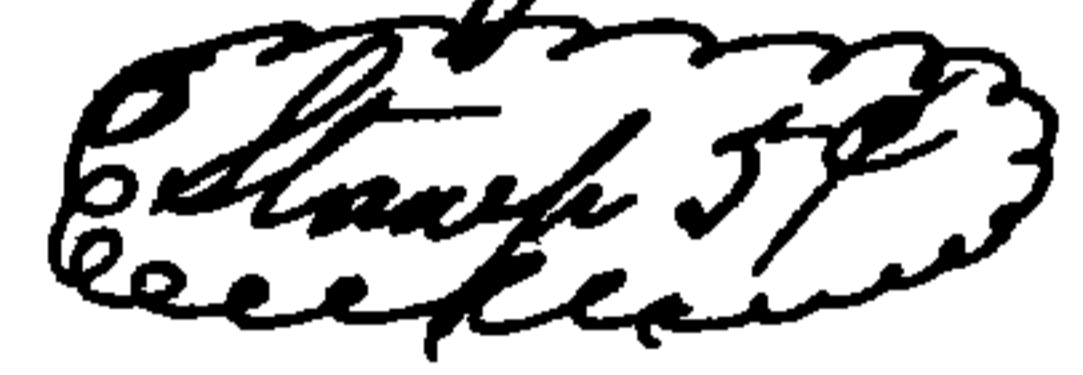

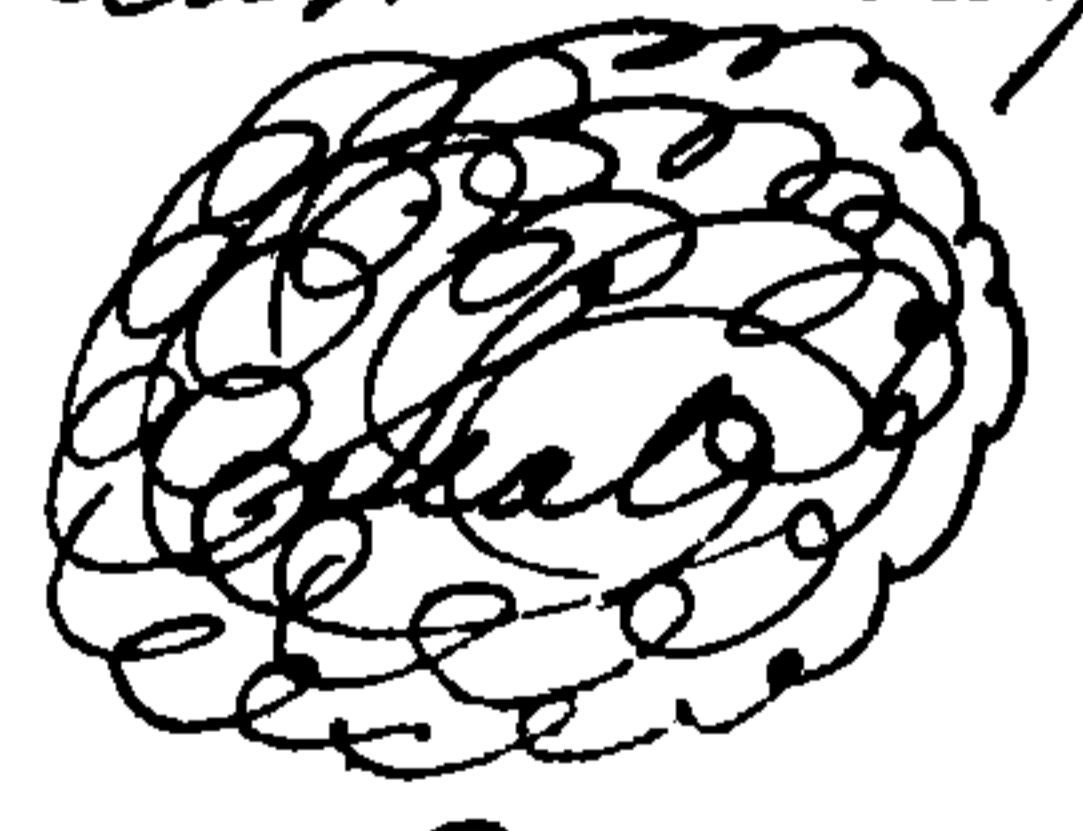

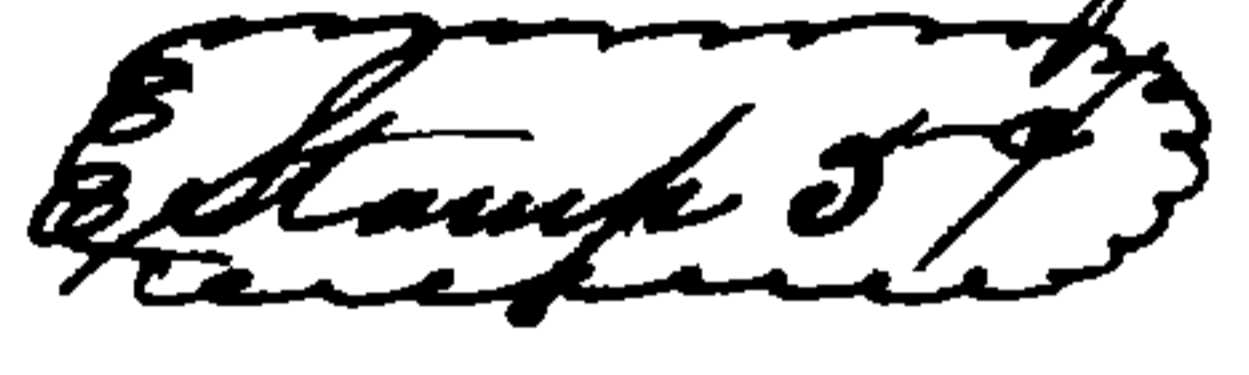
