Interrogatories to be propounded to witnesses to be examined on the part of the Complainants in the above Case. ~

- 1st Sub. - What is your name, age and place of residence? -
- 2^d Sub. - Do you know the parties to this Suit and each of them? And if yea, how long have you known them?
- 3^d Sub. - Did you know Francis Penn? And if yea, is he living or dead, when and where did he die?
- 4th Sub. - Did said Francis Penn, die intestate, or did he leave a Will?
- 5th Sub. - Did said Francis Penn leave a Widow, now living and if yea, what is her name, age, and state of health?
- 6th Sub. - Do you know the real estate of which said Francis Penn died seized and possessed? And if yea, look at Exhibits 1 & 2, now shown you and state whether or not the real estate described in said Exhibits is that of which said Francis Penn died seized and possessed, state all your knowledge therein. ~
- 7th Sub. - Did said Francis Penn leave any children or other heirs at Law? and if yea state their names, ages, places of residence, and whether married or single? And if married, state the names of their husbands or wives. ~
- 8th Sub. - What is the quantity and value of the real estate of which said Francis Penn died seized and possessed? State all your knowledge therein ~
- 9th Sub. - Look at Exhibit No 3, now shown you, and state whether the Land therein described is that of which said Francis Penn died seized and possessed, and whether the Francis Penn therein mentioned as grantor is or not one of the heirs at law of said Francis Penn Decd. ~ State all you know therein? -
- 10th Sub. - State whether or not said real estate of which said Francis Penn died seized and possessed, will admit of division amongst all said heirs at law or tenants in Common, without injury or loss, And if not, State your reasons for your opinion? ~
- 11th Sub. - Will it be to the interest and advantage of all said heirs at law & tenants in Common, infants as well as adults, for said real estate to be sold, and the proceeds distributed among them? And if yea, State fully why you think so? State all you know with reference thereto. ~
