Waters & Ann M. Waters, his wife, do grant in fee simple, unto Henry M. Stralman of the County and State aforesaid, all the following lot or parcel of a tract of land called The Mountain Tract & known and designated on the plat of said tract as Lot No 9, beginning for the same at a chestnut tree marked with nine notches, standing about one foot South of the closing line of the deed from John McPherson to F.
