

the said Henry Little and Ophelia Little his wife are non-residents of the State of Maryland that the other heirs at Law of the said Levi Grimes above mentioned reside in Frederick County & State of Maryland, Your Petitioner further alleges and charges that the said Levi Grimes died seized and possessed in common with Otho Grimes of certain Real Estate lying and being in Frederick County and State of Maryland and that on the 23rd day of September in the year 1871 a Bill was filed in your Honourable Court and in which cause it is prayed this Petition may be filed by the said Otho Grimes and — Grimes his Wife for the sale of the said Real Estate and a division of the proceeds of said sale among those entitled thereto. That the said Levi Grimes was possessed of a three fourths interest in said Real Estate as was alleged in said Bill, that a decree was passed by your Honors ordering the sale of said Real Estate, and that the same was sold for the sum of four hundred dollars upon the terms prescribed in said decree all of which will appear by reference to the proceedings above referred to, that said sum has not as yet been distributed among those entitled thereto. Your Petitioner further represents that the heirs at Law of the said Levi Grimes would be entitled to the three fourths of said sum after deducting all the expenses incurred in the above mentioned proceedings. To the end therefore that the funds arising from the sale of said Real Estate may be applied so far as is necessary in payment of the debts of the said Levi Grimes deceased Your Petitioner may have all the necessary relief. Your Petitioner therefore prays your Honors to grant subpoenas to issue to Otho Grimes, Lucy Grimes, Reinald Gough and Harriet Gough his wife, Levi F. Grimes of Frederick County John Brown and Mary S. Brown his wife George W. Beck & Margaret Beck his wife, Miss J. Crabbs and Harriet L. Crabbs his wife Alfred P. Hiteshew and Sophia J. Hiteshew his wife, Charles F. Rindollar and Martha A. Rindollar his wife and William Oliver Grimes an infant under twenty one years of age who reside in Carroll County Maryland commanding them to be and appear in your Honourable Court on a day to be therein named to answer the premises and abide by and perform such decree as may be passed therein, and further to grant an order of publication against the absent Defendants Henry Little and Ophelia Little his wife giving them notice of the contents of this Petition and to be and appear in your Honourable Court on a day to be named therein either in person or by solicitor and show cause why the application of the funds in this cause should not be made in payment of the debts of the said Levi Grimes deceased. And every day bond will ever pay &c.
