I drew up the Note and saw him sign them, there is some little credit due him on Mary Blaggett's Note for produce but I don't know how much.

4th *Sub*: He did, on Maryland Trust it is described in "Exhibit No. 4" it contains about three hundred and forty six acres of land more or less, is good farming land, run down a good deal and overworked, the Barn is in good condition and a fine one, the dwelling house is not in good condition the fencing is in tolerable condition.
