This indenture made this 19th day of February in the year of our Lord 1853 between Adam Shubbaum and Rachel Shubbaum his wife of Frederick County in the State of Maryland of the one part and Anthony Kimmel of the County and State aforesaid of the other part; Intenants that the said Adam Shubbaum and Rachel his wife for and in consideration of the sum of One hundred and two dollars Sixty two and a half cents current money to them in hand paid by the said Anthony Kimmel at and before the sealing and delivery of these presents the receipt whereof they the said Adam Shubbaum and Rachel his wife do hereby acknowledge have granted bargained sold aliened enfeoffed and confirmed and by these presents do grant bargain sell alien enfeoff and confirm unto him the said Anthony Kimmel his heirs and assigns all that part of a tract or parcel of Land lying and being in the County and State aforesaid and being part of a tract of Land called "Friendship" being part of the Land conveyed by John Myers to said Adam Shubbaum by deed bearing date the 1st of May 1848 for One hundred and Twenty Eight Acres beginning for the first hereby intended to be conveyed at a stone by a small Josephus Tree at the end of the 13th line of the deed from Richard Soale to Esau Drey dated the 25th of January 1814 for Two hundred Fifty three and three quarters Acres it being at the end of the Seventh line of the deed aforesaid from John Myers to said Adam Shubbaum for One hundred and Twenty Eight Acres and running thence by and with said Seventh line reversed North 79° 21' 23 1/2 ps to the middle of the County Road recently laid off it being at the end of the South 76 1/2° East 33 3/4 ps line of said road and with said road North 85° East 17 3/4 ps North 43 3/4° East 37 3/4 ps to the end of 6 3/4 ps on the 9th line of the deed aforesaid from John Myers to said Adam Shubbaum thence by and with the said 9th line reversed South 69° East 6 3/4 ps to a stone at the end of the 8th line thereof and with said 8th line reversed South 39° West 42 ps to the first mentioned place of beginning containing two Acres & thirty four perches of Land together with all and singular the buildings
