Testimony

At the execution of the annexed Commission issued out of the Circuit Court for Frederick County and to me directed and empowering me to examine evidences in the cause therein depending between Alexis J. Harbaugh Executor of the will of John Harbaugh of C. as Complainant and Lavinia Harbaugh and others as Defendants. William B. Nelson Commissioner therein named did on the 13th day of September 1874 at my Office in Frederick City Md. then and there proceed to take the following testimony to wit: The Complainant filed with the Commissioner as evidence "Colub's Nos 12.384" which are herewith returned by the said Commissioner, and there being no witnesses present to be examined and further time being required for the production of evidences the said Commission was adjourned to the 31st day of September 1874 at which time and at the place aforesaid I then and there proceeded to take the following depositions to wit:

Lewis Crawford, a witness of lawful age produced upon the part of the Complainant being duly sworn and examined to interrogatories filed with the Commissioner by the Complainant and herewith returned deposes and says to the,

1st Sub: I know all the parties for some years Lavinia William Adair of Sreal William David F. William and Catharine his wife Cornelius William and Harriett his wife, Ann Margaret William Samuel Worth and Mary Amanda his wife and James C. William reside in Frederick County Maryland, Josiah William and Sarah A. his wife reside in Idaho, Samuel William and Sabilla his wife George W. William and Matilda E. his wife and John F. William reside in the State of Missouri.

2nd Sub: I know him he lived in Frederick County Maryland he is dead I know the Lands of which he died seized John Harbaugh of C. owned it at the time of his death it is situated in "Harbaugh's Valley" Frederick County Maryland, I am well acquainted with the property and know that John Harbaugh of C. purchased the property of John Roddy and resided on it fifteen years and to within four years of his death.

3rd Sub: It was sold by A. J. Harbaugh acting Executor of John Harbaugh of C. to Sreal William the terms of sale were one third (1/3) Cash and the balance in (2) equal annual payments bearing interest from the date of possession Notes were not given, Sreal William failed to give the notes although he promised to do so but subsequently became
