This Deed made this 20th day September in the year 1866 by James A Gattou and Susannah A Gattou his wife William F Gattou Peter B Stouffer and Amanda C Stouffer his wife heirs at Law of B. F. Gattou deceased all of Frederick County and State of Maryland, Witnesses that in consideration of the sum of seven hundred and thirteen dollars the said James A Gattou and Susannah C Gattou his wife, William F. Gattou, Peter B Stouffer and Amanda C Stouffer his wife do grant in fee simple unto Harriet A Gattou an heir at Law of said deceased all their right title and interest both at Law and in Equity in and to all those Lots or parcels of ground with all the buildings thereon situate in the village of the Point of Rocks in said County and State and fully described in the following deeds to wit, in a deed from Robert Cassaway and Cornelia Cassaway his wife to the said Benjamin F Gattou bearing date the 7th day of March A. D. 1856 and recorded in Liber E. S. No. 7 folio 300, 304 one of the Land Records of said County and in a deed from Elias S Deblashmatt (tax collector) bearing date the 4th day of October A. D. 1843 and recorded in Liber W. B. D. No. 11. folio 3263 327 one of the Land Records of said County reference being had to said deeds will fully appear, and also all their right title and interest both at Law and in Equity in and to all that Lot or parcel of ground in said village lying immediately in the rear of the Lot of ground mentioned in the last aforesaid deed together with all the buildings and improvements thereon
