At the request of John Cochran the following Deed is recorded 10 March 1818 to wit:

This Indenture made the 15th day of November in the year of our Lord 1817 between Archibald Dorsey Lucy Dorsey of Baltimore County Paul Dorsey and Samuel F. Dorsey of Frederick County and all of the State of Maryland of the one part and John Cochran of Frederick County and State of Maryland of the other part; Witnesseth that for and in consideration of the sum of five dollars current money of the United States to them the said Archibald Dorsey Lucy Dorsey his wife Paul Dorsey and Samuel F. Dorsey in hand paid before the sealing and delivery of these presents the receipt whereof is hereby acknowledged and themselves to be fully satisfied contented and paid have given granted bargained sold aliened released subjeffed and confirmed and by these presents do give grant bargain sell alien release subjeff and confirm unto the said John Cochran all that part of a tract of land called "Williams Beginning" beginning for said part at a small Hickory Tree standing at the end of 65 1/2 ps on the division line between Samuel Dorsey and the heirs of William Dorsey and running thence South 82° East 129 ps to the end of 86 3/4 ps on the 20th line of said Williams Beginning and with the said line South 26° West 143 3/4 ps then South 86 3/4° West 146 1/2 ps to intersect at the end of 28 1/2 ps on the 50 line of "Williams Beginning" and with said land the two following courses and distances viz: 150° East 84 1/2 ps North 86° West 141 1/2 ps to the beginning of the divisional line between the said Samuel Dorsey and the heirs of William Dorsey and with the said line North 43 1/4° East 65 1/2 ps to the first piece of beginning containing 80 acres of Land more or less together with all and singular the advantages and improvements thereunto belonging or in any wise appertaining and all the Estate right title and interest claim and demand whatsoever whatsoever of them the said Archibald Dorsey Lucy Dorsey his wife Paul Dorsey and Samuel F. Dorsey of in and to the said part or parcel of land and premises hereby bargained and sold and every part and parcel, To have and to hold the above part or parcel of Land and premises hereby bargained and sold and part thereof with the appurtenances thereunto belonging unto him the said John Cochran his heirs and assigns to the only proper use and behoof of him the said John Cochran his heirs and assigns forever and they the said Archibald Dorsey Lucy Dorsey his wife Paul Dorsey and Samuel F. Dorsey for themselves and their respective heirs executors and Administrators do hereby covenant grant promise and agree to and with the said John Cochran his heirs Executors Administrators and assigns that they the said Archibald Dorsey Lucy Dorsey his wife Paul Dorsey and Samuel F. Dorsey and their heirs the said part or parcel of land and premises hereby bargained and sold and every part and parcel thereof with appurtenances thereunto belonging against them the said Archibald Dorsey Lucy Dorsey his wife Paul Dorsey and Samuel F. Dorsey and their heirs and against and against every other person or persons or persons whatsoever claiming or to claim any right title or interest in or to the same or any part thereof by force or under them or any of them unto the said John Cochran his heirs and assigns shall and will warrant and forever defend by these presents
