Having come to the conclusion that the Legislature had the right and power to pass the act of 1867, Ch. 100, which is general in its terms; it remains to determine its effect upon the deed of 29th of November 1866. It gives validity and effect to the defective acknowledgment, and the deed conveys to the grantee a good title to the land provided it does not vary, affect or divert any valid right the heirs at law of Benjamin Todd had in, or to the land at the time the law was passed by the Legislature. Benjamin Todd the grantor died the 31st December A.D. 1866, and the law was passed by the General Assembly on the 22^d of March A.D. 1867, and took effect on that day. Had the heirs at law any interest in the land at that time? If they had any interest in the property, it passed to them from Benjamin Todd immediately upon his death by operation of law, that is by descent or inheritance and they could only acquire by descent or inheritance the interest in said lands of which the intestate died seized.

At common law this deed would have been valid and effective in conveying all the interest of the grantor in the lands to the grantee; and the instrument is defective only because the parties did not follow the forms required by the Act, Code Art. 241.

The Legislature having by the Act of 1860, made these forms necessary to the validity of deeds and as it had been shown that the Legislature has the right to validate defective acknowledgments of deeds, and give to such acknowledgments the same force they would have had if formally made and certified at first, it follows that by exercising this power in passing the Act of 1867, Ch. 100, the acknowledgment is made correct and the deed made valid and effective to convey, in full and entire.

Judge Agnew, in *Shank vs. Brown* 61 Conn. Reps. 327, in deciding a case somewhat similar to the one now before this Court says, "In ordinary cases a married woman has both the title and the power to convey, or to mortgage her estate but is restricted merely in the manner of its exercise. This is a restriction it is competent to remove for the defect, and merely in the form of the proceeding, and not in any want of authority. Those to whom her estate descends, because of the omission of a prescribed form, are really not injured by the validation. It was in her power to cut them off and in truth and conscience she did so, though she failed at law they cannot complain, therefore, that the Legislature interferes to do further."

In the case of *Harrison Et al. vs. State*, use of *Harrison* 2d Md. 468, the Court of Appeals decided the Act of 1860, Ch. 271, which enacted "that all marriages heretofore made and celebrated in or out of this State by *** and between a man and his niece *** and made valid &c. from the time of the celebration of such marriage" to be a valid and Constitutional exercise of Legislative Power.
