At the request of George Harbaugh the following Deed was Recorded November 20th 1862.
(Stamp Tax paid)

This Deed made this Nineteenth day of November in the year of Our Lord One thousand Eight hundred and sixty two by Hiram Harbaugh and Jacob Harbaugh Executors of ^{William} Harbaugh (deceased). Whereas heretofore the hereinafter named George Harbaugh purchased of the said Elias Harbaugh in his life time the hereinafter described Real Estate at and for the sum of Two thousand One hundred and sixty seven Dollars, and whereas the said Elias Harbaugh departed this life before executing a Deed of Conveyance for the same, & whereas the said George Harbaugh has paid the whole of the purchase money aforesaid, & whereas the Orphans' Court for Frederick County on the 12th day of April A.D. 1859, passed an order directing the said Hiram Harbaugh and Jacob Harbaugh Executors as aforesaid to make a Deed of Conveyance of the said Land to the said George Harbaugh Now this Deed Witnesseth that in consideration of the Premises and of the said sum of two thousand one hundred and sixty seven dollars the said Hiram Harbaugh and Jacob Harbaugh Executors as aforesaid do grant in fee simple to the said George Harbaugh the following tract or part or part of a tract of land called "Elias & Nathaniel Harbaugh's Home" Beginning for the part hereby intended to be conveyed at a stone planted near the School House standing in the Main Road leading to Wagnersboro' being at the end of 46th line of the whole tract aforesaid and running thence with the out lines thereof Correcting same 2 Courses N 47 1/2° E, 237 1/2 yds to stone S 67 1/2° E, 18 1/2 yds to stone then with divisional line between George & Jacob Harbaugh N 78 1/2° E 153 yds to a stone at the end of 50 yds on the 10th line of the whole tract aforesaid and with it 3 Courses Correcting same N 23 1/2° W, 62 1/2 yds to heap of stones and a small hickory tree N 32 1/4° E 116 1/2 yds to stones in a Rock, N, 57 1/2° W 35 1/2 yds to stones, 1 half by divisional line of said Elias & Nathaniel Harbaugh's Home S 83 3/4° W, 117 yds to a stone at the end of 287 1/2 yds reversed on the 18th line aforesaid with said line Correcting same S 52° W, 28 1/2 yds to stake by side of small marked bassafras tree at the end of the said 18th line, then with divisional line between George and Hiram Harbaugh, viz: S 21° E, 157 1/2 yds to stones and marked Maple tree on the west side of the Road, and down the west side of said of the Road S 5° W, 67 yds to stones S 2 1/2° E 177 1/2 yds to stones S 12 1/2° East 48 1/2 yds to stone S 17 1/2° E 28 1/2 yds to marked Chestnut tree and stones then leaving the Road S 52° W, 33 1/2 yds to stones S 36° E 23 1/2 yds to stones on Bank of Friends Creek, S 42 1/2° W, 29 1/2 yds across the main Road to pile of stones, and then between George and Elias
