 for the purpose may be sold for payment of the claims of your
 Complainant and of the other unsatisfied creditors of the deceased, and
 that your Complainant may have such other or further relief in the premi-
 ses as equity may require - May it please your Honors to grant unto
 your Complainant the writ of Subpoena against the said Casper Myers
 Executor of the last will and testament of Mary M. Stonck, deceased,
 and against the said Vincent Myers, Casper Myers, and
 Ann L. Myers, his wife, William Henry Stonck and Leah Stonck
 his wife, Barbara M. Stonck, Catharine Stonck, Mary J. Stonck, Joseph
 A. J. Stonck and William E. H. Stonck commanding them to appear
 in this Court on some certain day to be therein named to answer
 the premises and abide by and perform such decree as may
 be passed therein. And may it further please your Honors to grant
 unto your Complainant an order of publication giving notice to the said

 and if dead to her unknown representatives of the substance and
 object of this bill, and warn them to appear in this Court in person or
 by solicitor on or before some certain day to be therein named to
 answer the premises and show cause if any they have why a
 decree ought not to pass as prayed
